#### **Outlines and Objectives**

Interact invites Programme Managers from different Interreg programmes to join this workshop on Annual Implementation Report and Performance Review.

The main objective of this day-and-a half-meeting is to discuss common challenges and share practical solutions relating to the Annual Implementation Report (AIR) and the Performance Review. We would like to highlight the expectations related to annual reporting and to reflect jointly on approaches to the challenging tasks in reporting. Next to these issues we will also discuss and develop preparatory steps for the AIRs 2019 which form the basis for the performance review.

Drafting the AIR is a recurring task; it might be challenging for persons new to the task but is also at risk to be considered as a mere compliance exercise by experienced staff.

One has to see that it is evidently more than a compliance exercise since it should provide a comprehensive but concise insight to the state of play in the programme – at first hand mainly for the MC and the EC. Result orientation as a guiding principle calls for qualitative information going beyond mere description towards the analysis of internal and external factors influencing the programme implementation.

Project-led debates in the MC meetings quite often do not provide sufficient room to

- reflect on cause-effect relations influencing programme performance
- discuss strategic issues
- pro-actively prepare preventive steps

The AIR should be understood as one vehicle to do so.

The year 2019 is a special one in terms of reporting: The Commission should undertake a performance review based on a performance framework and in cooperation with the Member States, in 2019. In practical terms it means that the AIR submitted in 2019 has to include comprehensive information on progress made based on the milestones included in the performance framework.

Throughout the whole event two members of the European Commission (John Walsh and David Alba) will be present.
