


Coordination and cooperation across programmes

4th Task Force meeting on coordination and cooperation across programmes Palau Reial de Pedralbes, Avinguda Diagonal, 686, 08034 Barcelona, Spain





Outline

During the events organised by Interact it was concluded that coordination and cooperation among Interreg programmes and beyond is not yet a daily practice but rather an exception. Therefore, in late 2016 Interact invited few Interreg programmes to come together and work on developing and describing different coordination and cooperation activities and experiences.

Throughout its work the group of Interreg programmes (Task Force) developed descriptions of activities for four coordination and cooperation levels (options), clarifying and providing for each of the descriptions: objectives, activities (ideas) on how the coordination and cooperation is/could be implemented, benefits and difficulties, sharing experiences as well as defining open issues/questions for improvement, especially post 2020.

Responding to the Task Force proposal, the meeting with Interreg Europe, Horizon 2020 and LIFE programmes was organised to discuss how coordination and cooperation between Interreg programmes and EU wide programmes could be improved now and in post 2020 period. Following up on the discussion, Task Force identified several further elements that could be exploited and suggestions provided to enhance coordination and cooperation, as such were identified:

- thematic coordination and cooperation;
- coordination and cooperation process as a part of programme implementation;
- coordination and cooperation: voluntary or compulsory;
- communication and promotion of coordination and cooperation practices.

Objectives

The objective of the meeting is to use the expertise of the Task Force members to collect, discuss and compile concrete ideas and suggestions with regard to coordination and cooperation focusing on the three aspects of processes, communication and thematic coordination and cooperation. The input provided by the Task Force during the meeting will be compiled into a summary document of the meeting which can serve as food for thoughts for any other stakeholder on how to make coordination and cooperation easier and daily reality.


