Outlines and Objectives

Interact invites representatives from Interreg programmes working on and with evaluations to join this workshop to discuss their experience with the indicators in the current period and also to reflect on options to make the indicator system fit for the future period.

Starting with a reflection of the experience of working with indicators in the current period we will discuss the current indicators system from different points of views.

First we will look at the final use of indicators in reporting process: The representative from DG Regio's Evaluation Unit will share some observations made with the Annual Implementation Reports for (AIR) for 2017 and the recommendations for the upcoming performance review.

Bearing these recommendations in mind we will invite the colleagues from the Interreg programmes to exchange on their daily experiences with the current indicator system focussing on questions such as: Which indicators haven proven to be clear and meaningful? Which indicators cause frequent misunderstandings and interpretation problems and what are the reasons? What are recurring obstacles in working with the (common) output indicators?

Based on this common understanding we will then examine the draft indicator system for the future period post 2020. What common indicators are foreseen in the new regulation? What indicators used in this period could also be used in the future period and might fit with minor changes into the proposed common framework? In which fields could Interreg programmes try to hamornise?

Finally, we will close the first day with an input to data quality management: the quality and reliability of data is an evident pre-condition for sound monitoring and performance reporting. And it is becoming also an element in system checks of Audit Authorities. Thus we would like to exchange on approaches to data quality management.

Throughout the whole second day we will work with the theory of change (ToC) in combination with methods applied in territorial impact assessment (TIA). We invite you to work on the intervention logic and ToC for two frequently used Thematic Objectives (the future policy objectives *Smarter Europe* and a *Europe closer to citizens*). Together we will go through the whole process of building an intervention logic based on the corresponding ToC.

As last step we will share perspectives on suitable indicators which could reflect the potential impacts of the future projects in these two intervention fields: this step will be based on the TIA method developed in the frame of ESPON. The whole day will be designed as a group exercise which allows you to learn the process of building an intervention logic, theory of change and TIA. The final outcome of the group work could maybe then be one beginning building block for your programming exercise, meaning you could use the building block as a starting point for your discussions and adapt it to your needs.

Throughout the workshop guidance and feedback will be available from representatives from the Evaluation Unit of DG Regio.
