General objectives of ESF+ - Art. 3

- All strands: Support the implementation of the European Pillar of Social Rights
- Shared management strand: also the Employment Guidelines and challenges identified in countryspecific recommendations and in the European Semester
- <u>EaSI Strand</u>: special focus on employment, skills, social protection, social inclusion and working conditions
- Health strand: ensure a high level of health protection in the Union





Specific objectives of the ESF+

EU Pillar of Social Rights

- (i) improving access to employment
- (ii) modernising labour market
- (iii) Promoting women's labour market participation, work/life balance, childcare, working environment, adaptation to change, active and healthy ageing
- (iv) Improving quality of education and training systems
- (v) Promoting equal access to education and training and lifelong learning,
- (vi) active inclusion
- (vii) integration of third country nationals and marginalised communities e.g. Roma;
- (ix) access to services; social protection healthcare systems and long term care
- (x) people at risk of poverty including / most deprived and children;

Specific objectives (SO) of ESF+ (Art. 4)

- 11 SO under "a more social Europe" (the CPR policy objective) in the policy areas of employment, education and inclusion including health;
- Wording closely follows the principles of the Pillar
- Specific references to third country nationals and basic material assistance
- ESF+ also contributes to other CPR policy objectives (a smarter Europe and a greener Europe)

Horizontal principles - Art. 6

- Mainstream and targeted actions to support:
 - equality between men and women
 - equal opportunities
 - non-discrimination
 - Promote the transition from residential/ institutional care to family and communitybased care.
 - The ESF+ should not support any action that contributes to segregation or to social exclusion.







- Stronger alignment with the European Semester and alignment with the European Pillar of Social Rights
- More flexibility on thematic concentration requirements: adjusted to MS needs
- The scope of the ESF+ is broader (basic material assistance and social integration measures) but fewer specific objectives
- Introduction of conditions for eligibility of direct staff costs and purchase of equipment, furniture and vehicles
- •Obligations on monitoring and reporting are simplified and indicators are reduced





Consistency & thematic concentration

- ESF+ resources have to be concentrated on challenges identified in NRP and European semester and take into account the Pillar
- Appropriate amount of ESF+ resources under shared management to support CSRs and challenges under the EU Semester



Programmed under one or more dedicated priorities (Art. 11)





Consistency & thematic concentration - Art. 7(1)

- Ensuring <u>coordination</u>, <u>complementarity</u> and <u>coherence</u> between the ESF+ and other Union funds or programmes.
- Avoid duplication of effort

How?

 Authorities of relevant programmes should be involved in the preparation and implementation of ESF+ programmes.

e.g The ESF can be used to top-up support by Erasmus, for instance, for students with a disadvantaged background



Consistency & thematic concentration - Art. 7(3)

- At least 25% of MS ESF+ resources has to be dedicated to social inclusion, i.e.:
 - Active inclusion
 - Socio-economic integration of third country nationals and marginalized communities
 - Equal access to services; modernisation of and access to social protection systems; healthcare and long-term care services
 - Social integration of people at risk of poverty or social exclusion
 - Material deprivation





Consistency & thematic concentration - Art. 7(4)

• At least 2% of the ESF+ resources of a MS has to address material deprivation (specific objective xi), but:

In duly justified cases, this may include support to the social integration of the most deprived (specific objective x)

Programmed under dedicated priority or programme (Art. 9)





Consistency & thematic concentration - Art. 7(5)

- MS with <u>high NEET rates</u> (above the Union average) in **2019** should programme at least **10%** of their ESF+ resources for **2021-2025** to support youth employment.
- •As part of the **midterm review**, MS will allocate at least 10% of their ESF+ resources for 2026-2027 to support youth employment if they have a <u>high</u> NEET rate in **2024**.
- For the outermost regions with <u>high NEET rates</u>:
 15% of the ESF+ resources in their programmes.

Programmed under dedicated priorities (Art. 10)



Partnership - Art. 8

- MS to ensure adequate participation of social partners and civil society organisations in the <u>delivery</u> of employment, education and social inclusion policies supported by the ESF+.
- Member States to allocate an appropriate amount of ESF+ resources in each programme for the capacity building of social partners and civil society organisations.









Support to policy innovation - Art. 13

- Member States shall support actions of social innovation and social experimentations and strengthen bottom-up approaches based on partnerships
- Member States may support up-scaling of innovative approaches tested on a small-scale (social experimentations) developed under the Employment and Social Innovation strand and other Union programmes.
- Can be done under any of the ESF+ specific objectives (i) to (x)



Programmed under dedicated priority higher EU co-financing rate

Eligibility of costs - Art. 14 Ineligible costs:

- purchase of land
- purchase of real estate
- purchase of infrastructure

<u>Purchase</u> of furniture, equipment and vehicles is only eligible if either:

- the purchase is necessary for achieving the objective of the operation; or
- they are fully depreciated; or
- or if the purchase of these items is the most economic option.

Direct staff costs are eligible provided that the level is not higher than 100% of the usual remuneration for the profession.



Indicators and reporting – Art. 15

- Common output and result indicators are set out in Annex I
- Shorter list of common indicators: decreased from 44 to 23
- Indicators are :
 - to be reported on by specific objective
 - to be broken down by gender (M/F/non-binary)
- When data are available in registers or equivalent sources, MS must enable MA to obtain data from these registers or equivalent sources.
- MS can only transmit data on a participant if his/her record contains the data for all common output indicators for participants (i.e. employment status/age/education level)
- Other common output indicators: if data for these indicators cannot be collected from registers, the values can be determined based on informed estimates by the beneficiary.









ESF+ support for addressing material deprivation

- Ensures continuation of support provided by the FEAD in 2014-2020 to OP I
- provision of food and basic material assistance (including through electronic vouchers) to the most deprived people, including accompanying measures
- CPR and ESF+ Reg. continues to provide for simpler requirements for this type of operations





ESF+ support for addressing material deprivation (2)

Due to the target group and the type of support certain requirements are simpler, e.g. audit and indicators and reporting

Relevant provisions in ESF +:

- content of programming (Article 18 ESF +)
- •eligibility of operations and expenditure (Article 19 and 20 ESF +)
- indicators and reporting (Article 21 and Annex II);
- audit (Article 22)



Eligibility of expenditure - Art. 20 (1)

The **eligible costs** of the ESF+ support for addressing material deprivation are:

- Cost of purchasing food and/or basic material assistance incl. cost related to their transport to the beneficiarie delivering the food/basic material assistance (point a)
- Where transport costs to beneficiaries are not included under poir
 a: flat rate of 1% on purchase costs to cover transport + storag
 or real costs when duly justified (pt b)
- administrative, transport and storage costs borne beneficiaries: flat rate of 5% on purchase costs (point c)
- cost of collection, transport, storage and distribution of food donations (point d)
- cost of accompanying measures: flat rate of 5% on purchas costs (point e)

Ineligible Costs:

- interest on debt
- provision of infrastructure
- costs of second-hand goods.



Indicators (Annex II of ESF + Regulation)

Changes to the indicator system

- Input indicators now covered in the Common Provisions regulation
- Output indicators: only total quantities of food distributed
- Use of informed estimates kept for result indicators

Structured surveys of end recipients

In 2024 and 2027 (to be defined in implementing act)

Evaluations: covered by CPR (Impact evaluation by June 2029; mid-term and retrospective by EC)





ESF+ support for addressing material deprivation

The Regulation proposal provides for full flexibility

ESF + support to address material deprivation can take two forms:

- Specific objective is part of comprehensive ESF + programme
- Specific programme exclusively addressing material deprivation

NB: Only the first option will benefit from the full flexibility, and linking social integration with activation.









EaSI strand - operational objectives

- Develop high-quality comparative analytical knowledge
- Facilitate information-sharing, mutual learning, peer reviews and dialogue
- Support social experimentations and build up the stakeholders' capacity to transfer and upscale social policy innovations
- Support services to employers and job-seekers
- Develop the market eco-system related to microfinance
- Support EU-level networking among relevant stakeholders
- Develop social enterprises and a social investment market
- Provide guidance for the development of social infrastructure
- Support transnational cooperation to facilitate the upscaling of innovative solutions
- Support the implementation of international social and labour standards



EaSI strand – eligible actions

- Analytical activities: e.g. surveys, studies, statistics, social experimentations, monitoring/assessment of the transposition and application of Union law.
- Policy implementation: e.g. cross-border partnerships, labour targeted mobility scheme, blending operations, development of social infrastructure and skills, transnational cooperation and partnerships.
- Capacity building: e.g. of EU-level networks, national contact points, participating countries administrations, social security institutions, employment services responsible, microfinance institutions, stakeholders involved in transnational cooperation.
- Communication and dissemination: e.g. mutual learning, peer reviews, benchmarking, guides, reports, informative material and media coverage, information systems, Presidency events, conferences and seminars.

- Associate countries or third countries (in accordance with specific agreements):
 - EEA members
 - Acceding countries, candidate countries and potential candidates
 - Other third countries
- International organizations





Health Strand - Specific and Operational objectives

- Specific objectives
 - Support health Promotion and disease prevention
 - Contribute to effectiveness, accessibility and resilience of health systems,
 - Make healthcare safer,
 - Reduce health inequalities,
 - Protect citizens from cross-border health threats
 - Support EU health legislation
- Operational objectives
 - Strengthen crisis preparedness, management and response
 - Empower health systems (disease prevention, digitalization, health information system, knowledge transfer, etc)
 - Support Union legislation
 - Support integrated work, e.g. networks





Health strand – eligible actions

- Analytical activities: e.g. surveys, studies, statistics, monitoring/assessment of the transposition and application of Union law.
- Policy implementation: e.g. cross-border partnerships, transnational cooperation and partnerships, health crisis preparedness exercises.
- Capacity building: e.g. of EU-level networks, national contact points, stakeholders.
- Communication and dissemination: e.g. mutual learning, peer reviews, benchmarking, guides, reports, informative material and media coverage, information systems, Presidency events, conferences and seminars.



Health strand - geographical scope

- EU Member States
- Associate countries or third countries (in accordance with specific agreements):
 - EEA members
 - Acceding countries, candidate countries and potential candidates
 - Other third countries
 - Neighborhood countries
- International organizations





Health strand - implementation

Commission assisted by Health Authorities of Member States

- Main interlocutor: Steering Group for Health Promotion and Disease Prevention
- Upstream and more interactive/productive consultations compared to current arrangements



Common provisions for the EaSI and Health strands - Art. 30-37

In addition to the rules specific for each programme, some common rules are also established concerning:

- Participation of associated third countries
- Forms of funding and methods of implementation: under the FR
- Work programme and coordination
- Monitoring and reporting, evaluation
- Protection of the financial interests of the Union
- Audit
- Information, communication and publicity









Final provisions - Art. 38-43

- The comitology committee for the ESF+ shared management strand is the one established by the future CPR
- ESF+ committee under Art. 163 TFEU for all ESF+ strands (incl. working groups for the different strands)
