## Synergies and thematic complementarities in Southern Europe and the Mediterranean.

# Main Findings on the table "Interreg and ENI investing priorities in Southern Europe and Mediterranean programmes".

#### Background

Synergies and complementarities between programmes are strongly linked to their common thematic priorities and challenges.

The table here provided hopes to be useful to the EU cooperation programmes to improve their cooperation and enrich the new approaches and initiatives currently being developed.

Despite the low amount of funds devoted to Interreg and ENI in the Southern Europe and Mediterranean comparing it with the whole of EU cohesion policy in the area, there is no doubt of the great value of these programmes for testing pilot actions that could been after enlarger to other funding sources as ESIF. Therefore, European cooperation can only have an impact if all involved actors work not only for their programme area, but also in favour of an overall shared objective <sup>1</sup>. This is what is called "creating synergies".

#### Objective

This document highlights the common thematic priorities and potential synergies between the cooperation programmes, as well as some relevant programmes state of play.

#### Methodology

This document is namely based on the desk analysis of **15** programmes <sup>2</sup> operating in the area. Here, specific objectives, investment priorities were checked. In addition to

this information a specific meeting took place last September 2018 where 8 EU Cooperation Programmes confirmed the desk analysis, shared about their funding allocation and new calls.

#### Thematic Priorities and Objectives.

In this programming period 2014-2020, the Southern Europe and Mediterranean programmes are focusing namely in the Thematic Priorities of Innovation and Environment, but Climate change and transport are also represented.

More precisely, programmes Interreg and Neighbourhood are investing in smart specialization and SME's entrepreneurship; natural risks, biodiversity and transport.

However, it is Natural and Cultural Heritage the common topic.

#### WEST MED INIATIVE and PANORAMED

8 programmes participated at the before mentioned Interact's meeting in Palermo, among these, 5 (INTERREG ITALY-MALTA, ENI ITALY- TUNISIA, ENI CBC MED, INTERREG MED and INTERREG ITALY-FRANCE MARITIMO) thought to be directly aligned with the WestMed Initiate goals.

INTERREG SOUTH WEST EUROPE, although does not have a specific maritime approach, there are or could be some projects that are aligned to the goals.

Despite ADRION and BALKAN MED are in the Mediterranean area, they are located in central and Easter Mediterranean where a Macrorregional Strategy (EUSAIR) is to be followed. Nevertheless, in the case of ADRION, it finds it interesting to follow the WestMed and seek also for complementarities. For BALKAN MED, it prefers to focus on a possible Eastern Mediterranean initiative or EUSAIR. In both cases there is not a specific maritime focus.

Regarding Panoramed, the 4 transnational programmes involved were also in the meeting and showed they will to cooperate.

#### State of Play

All these 8 programmes shared information on their state of play. The most relevant information was about the gap in the timing between Interreg programmes and ENI, with 1 year of difference. This is basically because of the approval of ENI and ETC (Interreg) regulations.

In the case of Interreg some of the programmes are already dealing with their last calls and most of their budget has been already allocated or it will be during 2019. Many projects have been already closed or will be in 2019 providing already some of their final results. On the other hand, the ENI programmes are still waiting for the final selection of their First call of projects during 2019.



Another main message is that the Programmes still have some funds available, namely for innovation and entrepreneurship, and only some few in cultural and natural heritage and biodiversity. However, some are also waiting for their level of projects expenditure to see if they can reinvest in new calls and capitalisation.
