### **Outline**

In the Commission's regulatory proposals, the objective of facilitating and increasing cooperation between regions and Member States within the 'mainstream' EU Cohesion policy programmes is underlined as a cross-cutting feature of the EU Cohesion policy post-2020. It means, actions and investments which have a higher EU added value when implemented jointly, should be promoted. The objective can be reached through, for instance, building synergies and supporting relevant priorities of the macro-regional strategies (MRS) and sea-basin strategies/initiatives (together herewith referred as Strategies) by European Structural and Investment funds programmes, increased funding for inter-regional innovation initiatives and investments in cross-border services or infrastructures. Moreover, it gives a strong and positive signal to key implementers of the Strategies to identify and communicate common core priorities.

While the present Strategies are not covering the whole Europe, they have a potential to model future transnational collaboration of the EU and its neighbouring countries at all governance levels, in search of impactful solutions to common challenges. The potential to encourage and to boost cooperation measures within programmes implemented under the Investment for jobs and growth goal is necessary. Therefore, existing strategic frameworks (like Strategies mentioned above) should not be underestimated or diminished.

Until the emergence of the Strategies, the role of the Cohesion Policy 'implementer' was played by projects of various sizes and scopes. Judging by the fact that the lion share of the EU Cohesion Policy funding is allocated at national and regional levels, cohesion was assumed to be assured through raising living standards within national borders and by implementing sizeable projects. In reality, most of the challenges pressing development of Europe today are broader in geography and more complex in scope and impact than any nation alone can manage.

The MRS and sea-basin strategies/ initiatives address cross-country wide common challenges, by working at two levels simultaneously:

• at a policy level – by sustaining and deepening generative, multi-stakeholder policy dialogues across the wider territory, and

• at implementation level – where existing and new policies get enacted and produce tangible impact 'on the ground'; by efforts of various actors gathered through the multi-level governance (MLG) principle inherent to the MRS.

Seen as strategic frameworks, the Strategies become the implementer of actions of appropriate size, scope and character – to match the level of cohesion challenge in Europe.

The link between the European Semester and EU Cohesion Policy is strengthened in the EC regulatory proposals for 2021-2027 period. The 2019 European Semester Country Reports will include an annex in which the Commission presents its view of the investment priorities, including cooperation, for each Member State.

In the Report on the implementation of MRS, the Commission emphasises the importance of a dialogue between EU programme authorities and key implementers the MRS. The Report says '...for each MRS, national authorities responsible for EU funds should jointly agree — in cooperation with MRS national coordinators — on main macro-regional priorities, measures, projects and governance mechanisms to be included in their respective



partnership agreements (EU Member States) and multi-annual programming (framework) documents (non-EU countries)'<sup>1</sup>. This meeting well contributes to continue discussion at MRS level.

The preparation phase of the post-2020 programming offers a unique opportunity to all EU Cohesion Policy programmes to address territorial challenges more strategically, through more coordinated and synergised actions stressing European added value of funding, and encouraging a dialogue between those involved in the EU Cohesion Policy programming and the Strategies.

### **Objectives**

This meeting is aiming at exchanging experiences and views between EU programme authorities on how to build synergies and embed cooperation activities in the ESIF programmes, where relevant. The MRS framework will be used for illustration on how cooperation between the ESIF programmes and MRS'/sea-basin strategies'/other initiatives' stakeholders can be built at national and transnational (macro-regional/sea-basin) levels for a mutual benefit of both. Participants will be invited to discuss and identify opportunities existing strategic frameworks can provide to the ESIF programmes' post-2020. We will focus on practical concerns regarding how to establish, facilitate and increase cooperation in a functional territory contributing to shared priorities.

The primary target group for this event are Managing Authorities of the ESIF (mainstream) programmes.
