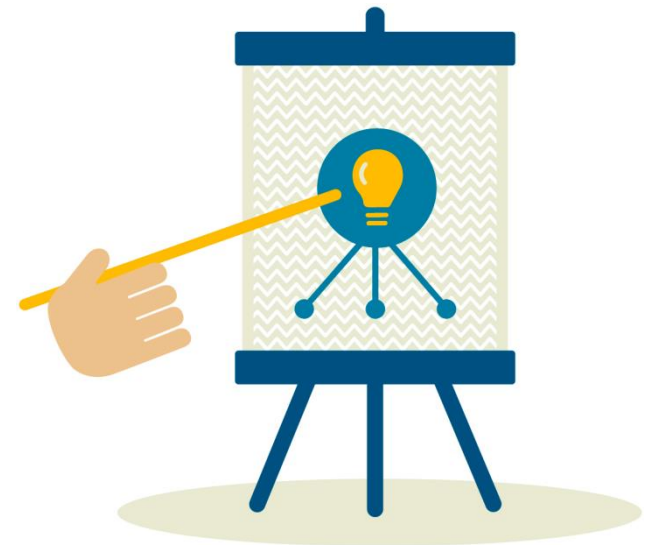

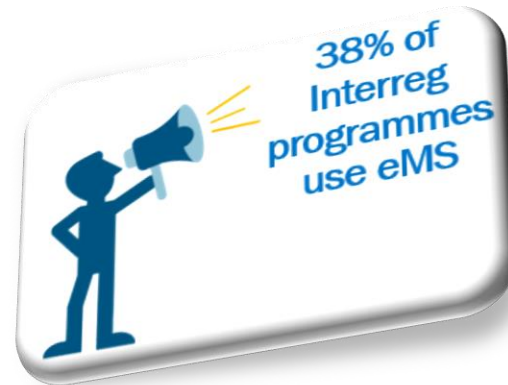

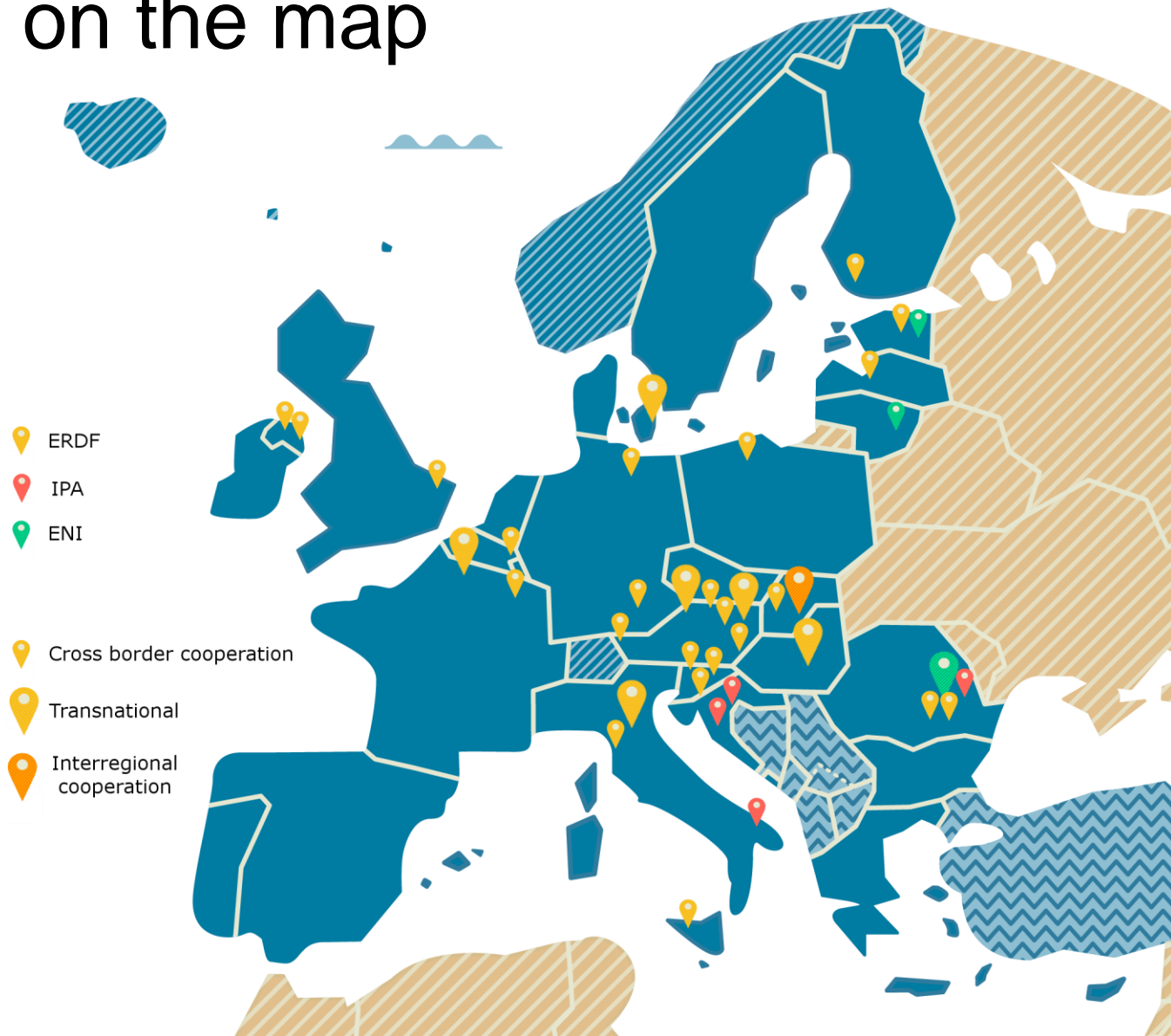
# eMS – What did we achieve?

- 37 (+2) signed license agreements:
  - 23 CBC programmes
  - 6 transnational programmes
  - 4 IPA CBC programmes
  - 3 ENI CBC programmes
  - Interact
  - (2 non-Interreg programmes)



***Savings for Interreg: up to 20 mio EUR!***

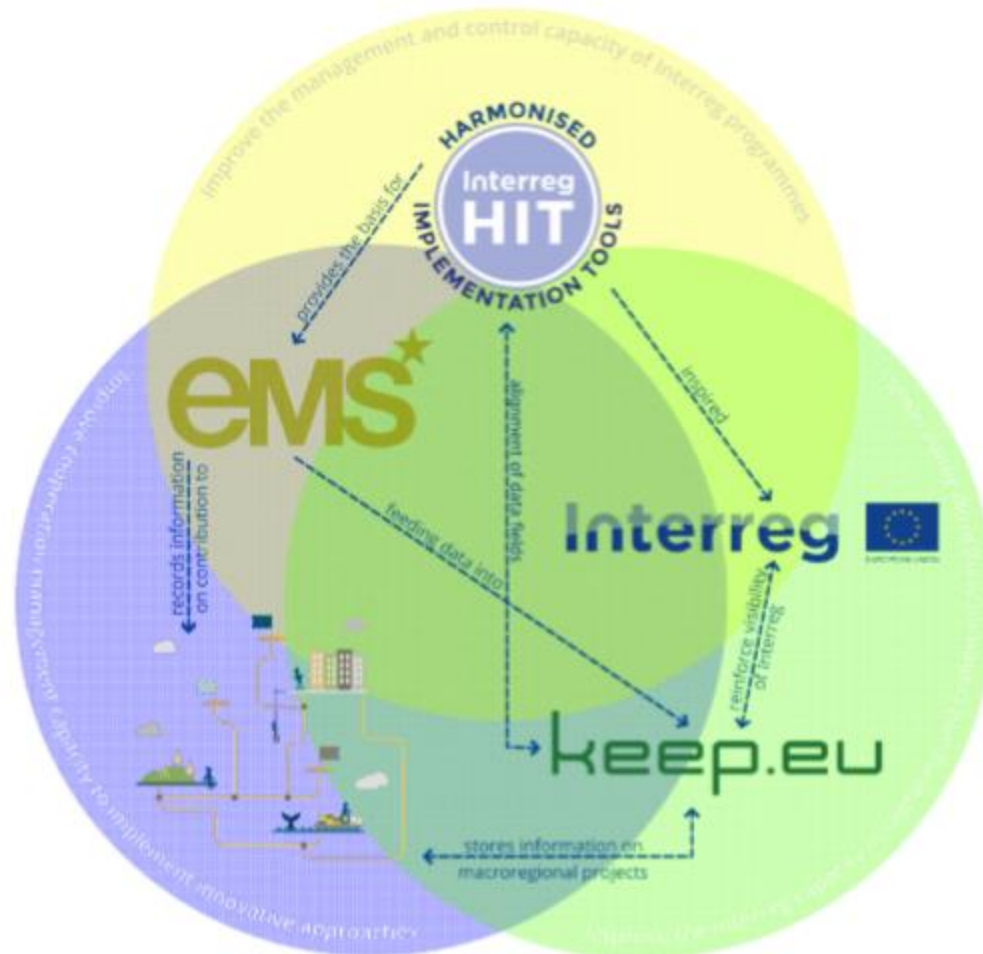
# eMS on the map



# eMS – What it does?

- Manages around **4 billion** Euros
- Supports around **60.000 users**
- Covers entire programme and project workflow
- Supports communication with beneficiaries and programme authorities (**JS/MA, CA**, controllers, **AA**)
- Supports generation of programme reports and payment claims to European Commission
- Supports sending data to **KEEP**

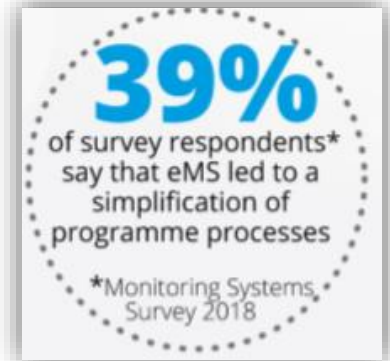

# eMS – key observations from Interact impact evaluation

## Building programme management capacities ...

...through changing practices/mindsets



### Between programmes:

- Community – building



### In programme authorities:

- Change to programme management processes
- Organisational flexibility
- Capacity for innovation
- Ability to manage change



### Through improved systems and tools

- Community monitoring system
- Programme – specific plug-ins

# eMS – key observations from Interact impact evaluation (1)

## Impacts found



### Efficiency

- Saves costs
- Saves staff resources
- Simplifies the application/reporting process and provides synergy effects

# eMS – key observations from Interact impact evaluation (2)

## Effectiveness



- Facilitates communication between programme authorities and improves transparency
- Promotes legal certainty for programmes
- Reduces errors that result from wrong data entry
- Positive effects on programme external communication



# eMS – key observations from Interact impact evaluation (3)

## Resilience



eMS was a big change in programmes introducing the system and required them to adopt a proactive approach to change management



“As a newly established programme, eMS not only helped us meet requirements on e-Cohesion, but also provided us with a system that is built on the collective programme management experience of the community of Interreg programmes.”
