Report

The training on Transports policy and how the concept of Sustainable transport is and will be taken into consideration yet during this financial period and also during the next period 2020-2027 raised a huge interest among the Interreg programmes but also among macro regional stakeholders.

More than 40 participants signed up for the event representing:

The aim was to get a comprehensive overview on what is happening in the field of Transport policy. The preparations were made in close cooperation within the network and with DG Move and DG Regio.

The concept of sustainable transport is very complex and has to do with many different aspects in society. The seminar focused on identifying processes and areas where Interreg can have its niche and make a difference.

For decades, transport has dealt about building and developing infrastructural solutions. It has been about roads, bridges, ports, railways, and airports and how to connect these. This is still part of the concept but it has become much more complex. As transport is causing a damage to the nature and humans, we need to look into the concept of

- how to achieve zero emissions
- alternative fuels for transport
- financial sustainability
- environmental resilience
- user friendliness for people and goods
- multimodal transport solutions
- how to handle bid data
- how to develop security issues

Objectives – identify processes and policies relevant for project funding

This was a learning event for the participants. Interact and the Interreg network for sustainable transport (TO7). The close cooperation with DG MOVE, compiled in a one-day seminar highlighted what has been done until now and what will be in the pipeline after 2020. It did not only focus on projects but on the steering policies and how programmes and beneficiaries can develop processes that leads to sustainable transport solutions. It was also a good opportunity to discuss how different funding sources can work together.

This meant it was meeting place not only for the network in itself but the network members got an opportunity to meet with leading actors from the whole EU Transport policy sector and vice versa. It became clear from the discussion that several of the reference points that people from e.g. DG Move referred to during presentations / discussions had been developed in an Interreg framework. One example of that is for example the feasibility plan on a new connection between Sweden and Denmark – the so-called HH- connection from Helsingborg to Helsingör (<https://www.hh-gruppen.org/>).

However, it was not only a learning event for the Interreg programmes and the thematic experts in the EU instances. It was also involving key stakeholders from the macro regional strategies. On top of that, three of the cases presented were also Interreg funded projects (sets of projects), that all have been earmarked as relevant for the individual macro regional strategies.

The learning event was set up as a seminar with presentations but it worked as a forum for discussion on how Interreg can make a difference in achieving safer and sustainable transport solutions. The date was also chosen so it was a back-to-back meeting with the Tentacle final conference in Brussels (6 March 2019). [Joint Final Event Brussels 5-6 March 2019 DRAFT PROGRAMME EXTERNAL.pdf](#)

The day was very dense but gave a lot of energy and insight in the field of transport policy. All presentations are available in the Interact community. We also planned to have an update the CEF2 development and to get a view from MEP Henna Virkkunen who was the CEF2 rapporteur in the EP. Unfortunately, for the seminar it was at a late stage decided that the final meeting for the Trilogies between Council, the European Parliament and the Commission took place the same day so we missed the opportunity to listen and discuss directly with MEP Henna Virkkunen.

The agreement during the trilogue was reached at that same day. EP adopted the outcome in the Parliament on 26 March 2019 - [see the link](#).

During the day 8 March 2019 two, the Interreg network reflected upon the learning event and shared ideas on what could be developed and how we can work closely together with the EU institutions in order to have the best possible outcome.

Linked to this the network had a discussion on the rest of the common activities for 2019 and it was agreed we will: 1) Develop a concept for the Civitas Forum in Graz, Austria 2-4 October based on the good experiences we had during TEN-T days in Ljubljana April 2018. 2) Cooperate with DG REGIO and DG MOVE to prepare for the conference on missing cross border links regarding rail and public transport, most likely in Mid-November in Brussels. 3) Prepare for a social media campaign to foster interest for a) and b) during the European Mobility week 16-22 September. The network did not show much of interest for attending the EWRC so we agreed to focus on a-c.

During the Day 2, the network also got a presentation based upon keep.eu (Janne Kiilunen, Interact – on distance) and its capacities to share knowledge about what is happening in other programmes and ideas about how to use keep.eu as part of the

capitalisation process. Finally, CE/Winfried Ritt described how CE is working with the Capitalisation issues as inspiration for the network. It was also agreed to highlight different capitalisation initiatives for the programmes in the network as inspiration and knowledge sharing also in the future.
