### **Outlines**

Building on the positive experience of the first two network meetings of finance officers of CBC programmes, Interact is organising the 3<sup>rd</sup> network meeting for experienced finance officers of Interreg CBC programmes.

This meeting will continue the exchange and network activities between the finance officers of the cross-border programmes. The event is designed to create a space for exchange on various finance-related issues, relevant for all cross-border programmes. Participants will gain an understanding and overview of approaches applied by different programmes when tackling financial issues; they will share ideas and work together towards solutions to common challenges.

### **Objectives**

The main objective of the meeting is to work on simplified costs options used currently and plans to enlarge its usage for post 2020. We are planning also to cover the topic of financial instruments to discuss its potential, future use. We would also like to focus on future programming perspective and challenges already foreseen related to financial programme management.

To ensure participation of a wide range of programmes in the network meeting, the participation will be limited to 2 representatives per programme/ Member State (depends on the demand).


