

Evaluation, Capitalisation and Communication







Outline and Objectives

Interact invites evaluation and communication managers of Interreg programmes to join us at this workshop Evaluation, Capitalisation and Communication (EVAL-CAP-COM) on 5-6 November in Budapest.

The main aim of this two-day workshop is to exchange on the experiences of Interreg programmes on how to:

- use evaluation findings for the capitalisation process:
- communicate these findings; and finally –
- use the evaluation results for the programming process for the post 2020 period.

In the beginning of the event you will hear how the Evaluation Unit of DG REGIO has analysed the first evaluation reports in this period and what are the main lessons learned in this process.

In the following sessions, we will exchange on the experiences of the representatives of the Interreg programmes how the evaluation findings have been used in their programmes. If evaluations are properly carried out the findings can become one of the cornerstones of a valuable learning exercise. Ideally speaking the findings:

- should be a crucial element for the programmes to develop respectively expand their capitalization activities
- should be used for communication matters to shape the picture about the programme
- should contain important facts and conclusions for the programming post 2020

We are aware that this easily put but difficult to achieve. We will discuss strategies and levers to approach this ideal.

In the second day the communication and evaluation managers will be divided into two separate groups in different break out rooms.

- The evaluation managers will exchange on their status quo of their evaluation process, in the operational as well as the impact evaluations
- The communication managers will exchange on assessments / evaluations of the communication strategy

Throughout the event David Alba of the Evaluation Unit, European Commission will be present.
