

Small Project Fund



A tool within the Interreg V-A SKHU cooperation programme to implement projects with small total budget.

Objective SPF - to strengthen social cohesion across the borders by supporting local level cooperation and to establish and improve long-term collaboration between actors on both sides of the border through the support of regional projects.

The Small Project Fund is implemented under two priority axes of the Interreg V-A Slovakia-Hungary Cooperation Programme:



PA1 Nature and Culture



PA4 Enhancing cross-border cooperation of public authorities and people living in the border area


