Outline

Harmonisation of practices in Interreg programme and project management has started many years ago and it continues while we are preparing for the next programming period. In this period (2014-2020) Interreg programmes harmonised implementation tools (templates and guidance documents) used for selection and monitoring of Interreg projects. The HIT tools are: application form, assessment criteria and checklists, progress reports, management verification templates.

HIT was taken up by 60% of Interreg programmes and it provided more harmonised interpretation of regulatory requirements for many more. This led to increased legal certainty for programme authorities given this large number of adopters. The impact evaluation found out that HIT contributed to a more efficient programme implementation as it offered off-the-shelf implementation tools in line with EU regulations and guidance, sparing programmes from having to develop tools on their own. Above all, HIT achieved simplification for actors working in multiple programmes, including Interreg applicants, beneficiaries, and national controllers.

With the existence of HIT, a harmonised approach to programme management was created. Only with this harmonisation, it was possible to create the electronic monitoring system.

In 2019 the process of developing HIT for 2021-2027 period started. A HIT Core Group has been established - 25 programmes from all strands are participating in the group. The group met already several times. The task is to update and optimise HIT tools from 2014-2020. Focus is on changes required by the regulatory framework and simplification for projects and programme bodies.

Tools (mainly application form) used in the project selection process will be available as final drafts by May. To enable smooth implementation of these tools we are inviting all Interreg programmes, including IPA CBC and ENI programmes, to an online question and answers session where we will explain the underlying approaches used in HIT tools. Participants will have an opportunity to ask detailed questions and discuss potential challenges in project selection in the next period.
