



# A coordinated approach to shared priorities



**11 December 2020 Cross-border cooperation programmes aiming for more territorial impact in the Baltic Sea region** Online 9:00-11:00 and 13:00-15:00 CET







### Outline

The EUSBSR is established to identify common needs, problems and opportunities that can be fully exploited only by building and strengthening cooperation that goes beyond borders, sectors and governance levels. The EUSBSR offer an agile and strategic framework for long-term cooperation on clearly defined priorities and actions. The macro-regional strategy as a policy-action framework intended to tackle common complex challenges in an integrated manner, i.e. through alignment of policy, funding and action.

The draft regulatory proposals for 2021-2027 Cohesion Policy underline cooperation as a horizontal objective. The EUSBSR and strategies of partner countries serve well the purpose of building complementarities and synergies across the programmes. Taking this into account, in 2020, Interact organised Interreg programmes' meetings discussing territorial impact and coordination.

The overall aim of this regional forum is to raise awareness among the programmes on thematic focus of other programmes in 2021-2027, and to discuss potentials for synergies in the Baltic Sea Region. Building on earlier exchanges, this meeting will share ideas and discuss ways on how cross-border cooperation programmes can meaningfully and purposefully contribute to shared territorial challenges of the Baltic Sea Region.

Main target groups for the meeting are Interreg and ENI cross-border cooperation programmes representatives (National Authorities, Managing Authorities or Joint Secretariats) and the EU Strategy for the Baltic Sea Region (EUSBSR) policy area coordinators.

### **Objective**

The objective of the meeting is to provide an opportunity for the programmes and policy area coordinators of the EU Strategy for the Baltic Sea Region (EUSBSR) to get together.

The event will invite participants to exchange practical ways on how cross-border cooperation programmes can play a more active role in implementing shared priorities of the EUSBSR and the strategies of the partner countries. Participants will have an opportunity to raise awareness and clarify uncertainties related to the embedding of the EUSBSR to meet the requirements of the Art 17.4 iv of the draft Interreg regulation.

Secondly (for strategy stakeholders), the session allows to build knowledge and understanding of Interreg and ENI cross-border cooperation programmes. Both groups will be invited to formulate suggestions for closer collaboration and define open questions to the other group to be discussed jointly. These inputs will shape the discussion during the afternoon session.
