

Asylum, Migration and Integration Fund - Objectives





Asylum, Migration and Integration Fund (AMIF)

- » **original global allocation** for 2014-2020: 3,1 bn euro (incl. 765 mill euro for integration in NPs)
- » increased for 2015 and 2016 incl. the emergency assistance but more needed, top-up including for integration in 2017 allocation
- » **scope:** asylum (reception, decision-making, resettlement, capacity building), legal migration and integration (important emphasis on the local and regional level, return (encouraging voluntary returns) and solidarity (better sharing of responsibility between MS))




Asylum, Migration and Integration Fund for 2014 + 2015 + 2016

**Total for Asylum, Migration
and Integration Fund
2014 + 2015 + 2016
= €2 105 960 771**

- EU Emergency Asylum 23%
- EU Grants on Asylum 2%
- EU Grants Integration and Return 3%

- » HOME Funds legal basis (HR 514/2014, art. 14.2e), 5.f), AMIF Reg.516/2014 rec. (22)/integration, art.9(4), CPR 1303/2013 art.4 (2), (6)/complementarity, coordination, ESF Reg.1304/2013 rec. (6) and art. 2/migrants
- » AMIF national programmes (reporting through AIRs)
- » current context with the migratory crisis and bigger and more urgent needs in Migration and Home Affaires areas
- » Action Plan on the Integration of third-country nationals and December 2016 Council Conclusions
- » request from MS and stakeholders
