#### **Outline**

Management verifications is one of the areas that has been significantly modified in the 2021-2027 period to simplify control work and reduce administrative burden.

This workshop targets controllers performing management verifications in Interreg programmes. We would like to invite new staff and experienced controllers to join the workshop. We will look at the new provisions for the 2021-2027 period from the controllers' perspective and focus on the main changes in management verifications. Also, there will be a chance to discuss the HIT results (Harmonised implementation tools) work regarding risk-based management verifications.

Another hot topic on the agenda is simplified cost options as many more Interreg programmes start to make sure of them. We will look at how common types of SCOs are verified in practice and exchange common eligibility questions. Lastly, we would also like to exchange good and not-so-good practices concerning control work (gold plating examples and how we could address them in the future).
