The keep.eu 3.0 Group has been working for the past couple of years to reach an understanding on how keep.eu should evolve to take in the 2021-2027 programming period.

Among the issues that were discussed in this Group, the following should be highlighted:

- The 2021-2027 intervention logic
- The sources and links of keep.eu: Regulations, HIT, Jems, Kohesio
- Kohesio, EU Cohesion Policy's knowledge database of projects and partners
- Keep.eu 2021-2027 programme, project and partner fields
- Keep.eu website, its evolution into the 2021-2027 programming period
- Keep.eu hosting the 2021-2027 programmes' Lists of Operations (LoOps)
- The PIC (*Participant Identification Code*) and public data of legal entities
- Keep.eu's wealth of partner data, *match-making* tool

Steered by the discussions in the keep.eu 3.0 Group, Interact has now adjusted keep.eu to the 2021-2027 intervention logic, made sure of its alignment with HIT, Jems and Kohesio, developed the LoOp template for all Interreg programmes to use, included the PIC among the partner fields, and further developed the website logic to expand the potential of its *match-making* tool.

Objectives

The participants will be presented at this meeting with all the developments that the keep.eu 3.0 Group discussed previously and proposed to Interact, both at the plenary meetings and in focus groups.

They will be able to give their opinions on the choices that were made on top of what they previously conveyed to Interact. Importantly, they will also be brought up to speed about the state of play of Kohesio, and the relationship between Kohesio and keep.eu.
