## Solutions

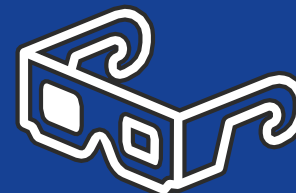
- We wanted to use existing Word documents.
