- MA, CA, AA in Denmark
- No new Interreg 5 programme in this geographical setup





Projects closing

10 focus themes within 2 priority axes

Total number of projects: 37 Projects closed between 2010 and 2014: 19

Challenge in 2015/2016: 18 projects to close

achievement so far: "last" payment claim in Dec. 2015







Projects closing

- 4 projects (= 8 LP/PP): 2nd level control in 2016
- Challenge: to finalise in time. How to make a possible reclaim pleasant and effective?
- Process of working on communication of programme results: iPaper
- In general: a strong cooperation achieved among many different stakeholders in the region with both hard and soft outputs/results

Challenge: no longer political focus on Interreg IV A

Challenge: estimate the size of the closure tasks: politicians and HR managers want to know numbers of hours and a clear list of tasks – both is unrealistic!

Challenge: staff leaving
