

Synergies in the Mediterranean during Implementation 21 and 22 March 2023

About the Med Lab Group

The Med Lab Group is a multilevel platform of all Interreg programmes in the entire Mediterranean to discuss jointly and in practical terms WHY, WHAT, WHO, HOW to work in **synergies**, and to explore the needs and **inter-programme coordination** solutions.

Within the new programming period the renowned calls for a more integrated approach to sectoral and/or territorial policy implementation are being raised. In the meanwhile, the Commission encouraged through the Orientation Papers a stronger cooperation between programmes operating within the same area encompassing transnational (TN) and cross-border cooperation (CBC), including Interreg NEXT. There is no doubt that working together, promoting common objectives, and reinforcing synergies between programmes leads to a higher EU added value, a stronger impact in the area, a better allocation of public resources and improves the capacities of the programme authorities and beneficiaries. In this spirit and within this goal the Investment for Growth and Jobs programmes are encouraged to use cooperation more actively.

Interreg programmes operate in a specific territory/geographical area, thus, give response to territorial challenges. Based on this reality, improving synergies and inter-coordination of the operations implemented by the most appropriate geographical scale can increase its efficiency when giving response to territorial challenges. For the past two years Interact and TESIM have been facilitating this process in the Mediterranean region focusing on the 2021-2027 programming.

After 7 events, 2 tools and the nurturing of a community based on the partnership principle and the multilevel governance, Interact and TESIM together with the European Commission will continue supporting programmes in this task during the implementation phase.

Starting from the first quarter of 2023, our work will build on three complementary perspectives:

- 1. **The Project/Programme cycle dimension**, where the lifespan of programmes and projects is stressed, optimising synergies all along the different phases of the programming cycle, from the design of calls to the capitalisation of results;
- 2. **Thematic approach**, where the convergence of programmes and projects into policy and specific objectives and indicative actions is the key and where tools intended to maximise synergies among actions addressing common topics in the core dimension;
- 3. **The Territorial impact**, where the focus is on the geographical dimension of cooperation and where synergies are exploited in their potential to add value at territorial level, valorising the effort of project partners on transforming cooperation into an asset at local level.

Objectives

After a long period of Task Force meetings, all programmes in the Mediterranean area have been approved. This meeting will be the first one in 2023 and it will focus on the following objectives:

1. For the Project/Programme cycle dimension, we will address the first steps of the programme's implementation cycle, notably calls and projects' assessments: How synergies and complementarities are considered in your 2021-2027 calls and assessments? What are you thinking about more precisely and why?

- 2. For the Thematic approach, we will start investigating and exchanging on the most popular topics selected by most of the programmes and through parallel sessions we will explore possible synergies under the environmental dimension (PO2) and specifically on under the specific objective addressing **Biodiversity & Natural protection** (SO 2.7) and under the social and socio-economic dimension, focusing on the topics around popular theme of **Sustainable Tourism** (SO 4.6).
- For the Territorial impact, we will switch into an experiential and bottom-up approach based first
 on a project visit linked to EUSAIR and afterward on a common reflection on the added value
 of TN/CBC synergies at local level.

1st day: Presential for plenary, working groups and networking and live streaming options only for plenary sessions

2nd day: In person site visit + follow-up & networking session
