Interact organises this recurring event with our colleagues from the Managing Authority INTERREG 2021-2027 based in Thessaloniki – Greece. The network was kicked off in 2018, with physical meetings in Thessaloniki, following the needs assessment led throughout the Southern Member States. The network has a practical problem-solving approach, focusing on exchanging information, sharing experiences, practices, and lessons learned concerning management verifications and transferring the necessary knowledge to their controllers. 
